CASE STUDY: DRAM SHOP LIABILITY

Under Texas dram shop laws, an establishment that serves alcohol to a person who is obviously intoxicated can be held liable for the actions of the customer if he later harms someone.

This was exactly the situation on Feb. 1, 2014, when our client, a college student from the DFW area, was hit by a drunk driver after leaving work at 3:30 in the afternoon. In pursuing compensation for her devastating injuries, we discovered that the drunk driver had been served a significant amount of alcohol by a Lubbock bar despite being intoxicated when he arrived there.

Brad immediately began gathering evidence such as video footage, witness statements and receipts. After our client had completed her medical treatment, a demand was prepared demonstrating the unquestionable liability of the bar in overserving its customer.

Our client's family had mounting medical bills to pay and a trial could have meant they would not see any money for months, if not years. When presented by the evidence that had been gathered by Brad and his team, the bar agreed to settle for a confidential amount.





I WAS IN A MINOR ACCIDENT... WHAT DO I DO NOW?

A car accident can be terrifying, but there are steps that can be taken by someone who has been involved in a crash that will decrease the stress and likelihood that additional problems will arise.

SETTLE IT MYSELF?

1. Move to Safety

If you and anyone in your vehicle are not seriously injured, attempt to move the vehicle to the side of the road and out of danger.

2. Contact the Other Driver

After you've gotten to safety, attempt to make contact with the other driver politely and as calmly as possible. Offer to exchange contact and insurance information.



When the police arrive, provide as many details as you can recall, but do not engage in arguing your position at this time.

4. Take Pictures of the Scene

Take pictures of the scene where the accident occurred including pictures of the surrounding area, street signs, damage to your car, damage to other cars and property, as well as pictures of the other driver and witnesses.

5. Locate and Get Witness Information

If there are witnesses to the accident that actually hang around, be sure to get their complete contact information.

6. Seek Professional Medical Help

After the accident scene has cleared, you need to seek medical attention even if you don't think you've been seriously harmed.

7. Obtain a Copy of the Crash Report

To obtain a police report, one must visit the Texas Department of Transportation website and submit a search and purchase for the Texas Peace Officer's Crash Reports (CR-3).

Bredele. Biscuits de Noël

Alsace, the region in the east of France on the border with Germany, is the emblematic 'capital of Christmas". There you will find delicious treats like mulled wine, charcuterie, gingerbread figures, and most definitely you'll find the quaint bredele.

INGREDIENTS:

- 3 ¼ cups flour
- 18 tablespoons butter, at room temperature, cut into small pieces
- 1 ¼ cups sugar
- 1 teaspoon cinnamon
- zest of 1 lemon
- 3 eggs
- 1 egg yolk
- 1. Place flour in a large bowl. Make a well in the center, and add the butter. With your fingers, mix the butter with flour until sandy. Add the sugar, cinnamon, lemon zest and the whole eggs. Mix well to obtain a smooth dough. If the dough seems too dry, add another egg.
- 2. Wrap the dough in plastic wrap and allow it to rest overnight, or for at least 6 hours.
- 3. When ready to bake the bredele, preheat oven to 355 degrees. Roll out dough on a floured surface to 3/16-inch thickness. Cut dough into desired shapes with cookie cutters. Place cookies on a buttered cookie sheet.
- 4. Beat the egg yolk with a fork, and brush cookies with egg wash.
- 5. Bake for 15 minutes. Let the cookies cool.
